# **Pesticide Applicators Licensing and Recertification**

Ron F. Meyer (Golden Plains Agronomist) & Bruce Bosley Currently, there are two groups of agricultural pesticide applicators who are required to be licensed with the Colorado Department of Agriculture (CDA). Licenses are divided into Private applicators and Commercial applicators.

Private applicators are those producers who apply pesticides on the land they farm (owned or rented). As the Colorado statutes are written, private applicators may not apply pesticides for a fee to anyone or they will be classified as commercial applicators. In addition, private applicators only need to be licensed to apply restricted-use pesticides. Non restricted-use pesticides do not require a license to purchase.

Commercial applicators are those who apply pesticides for a fee, regardless of the type of pesticide.

Both private and commercial applicators must be licensed before they can purchase restricted-use pesticides. Keep in mind that the old EPA pesticide licenses are valid in Colorado only until they expire. Therefore, applicators that hold the old cards will need to take the new CDA test to become current. Anybody can order a test directly from the CDA or stop in at one of the Colorado State University Extension offices, as many offices continue to carry them. In addition, some agricultural retailers also have tests available.

Once licensed, applicators can either collect continuing education credits (CEC) or retake the test when renewal is required. Private applicators need 7 CEC's within a three year period in order to renew their license without testing. Commercial applicators need not only the 7 "Core" CED's, but also additional category credits.

# Colorado AgrAbility Project Did vou know?

Colorado agriculture is a big, dangerous business. The state has 28,268 farms and it had 78 agricultural fatalities 1997-2000. Colorado has 1,600 injury compensation claims for agricultural-related injuries that result in a loss of over \$8 million each year. There are an estimated 6,965-10,882 farmers/ranchers with disabilities.

# **Logan County Prairie Dog Control Rebate Program** Bruce Bosley



Logan County Pest District will be continuing it's Prairie Dog Control Rebate Program for the 2010 and 2011 management season. The Logan County Extension Office will be handling this program until a Pest District Supervisor is hired by Logan County later this year.

This program is available to all Logan County
Landowners who wish to control prairie dogs on their Logan
County property. This rebate program is limited to the use of
Rozol® prairie dog bait. Rozol® is a Restricted Use Pesticide that
can only be applied by a Licensed Pesticide Applicator in active
prairie dog towns during the period of October 1st 2011 until
March 15th 2012. Rozol® bait must be purchased at a Logan
county pesticide/bait retailer. Receipts from the purchases need
to be included with the rebate application.

Pick up rebate applications at the Logan County Extension office. The deadline for receiving completed rebate applications at the Logan Extension office is April 1<sup>st</sup> 2012.

The application form requires the following information: the landowner's name, address, and phone number, the Colorado License number of the pesticide applicator who made the bait applications, the legal descriptions of where each application was made within Logan County, and how much bait was used at each location. Receipts for prairie dog bait purchases are also required to complete the application.
